Voluntary fees such as FSA Hot Lunch, Bearcat Sweats, Athletic fees, Milk, and Yearbook must be paid directly to the sponsoring group.

Please note that the cost of an education at St. Luke School (\$6,000 per student) is NOT fully covered by the tuition charged. ALL students are subsidized by our generous benefactors. Currently, approximately \$1,400 is needed per student from non-tuition sources such as school fundraising, Parish support and from invested earnings of the School Endowment Fund.
